Strategy

The Fund uses a disciplined approach of allocating assets among the three major asset groups: common stocks, debt securities (bonds) and cash equivalents. Based on the Adviser's assessment of market conditions, the Fund will invest 25% to 75% of its total assets in stocks and convertible securities, and at least 25% of its total assets in bonds.

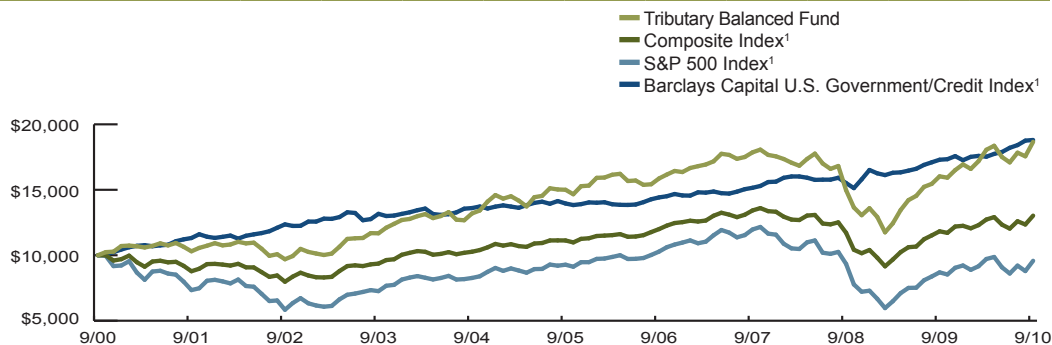

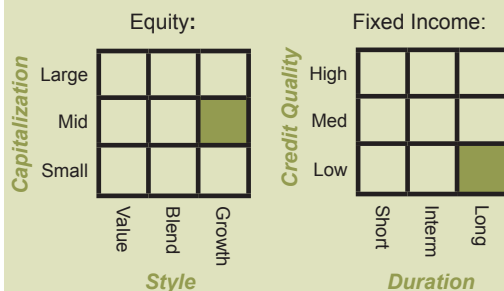

Manager Commentary

During the third quarter, the Tributary Balanced Fund continued to outperform its peer group. The key to the strong performance was stock selection. In equities, Potash, Citrix Systems, Agrium and Netflix, Borg Warner and Joy Global made positive contributions. In fixed income, the Fund benefited from the longer duration of the portfolio and focus on credit relative to government bonds. During the quarter, we increased the stock allocation from 59% to 63% as of September 30th.

The outlook is positive with equities trading at a discount to historical valuations. Companies in the S&P 500 are expected to grow earnings in 2010 by 34%, yet the Index has only returned 4% year-to-date. Effectively, the stock market is 30% cheaper on an earnings basis. Other indications of value include the increase in mergers and acquisition activity and share buybacks. As a result of the relative attractiveness of equities, we have been increasing the stock allocation. The risk to Fund returns is the possibility of a double-dip recession. We continue to closely monitor leading economic indicators and employment statistics. If our 2011 economic outlook deteriorates, we will become more defensive in asset allocation. In fixed income, we are finding value in corporate and taxable municipal bonds.

First National Fund Advisers, a division of First National Bank located in Fort Collins, Colorado serves as the Fund's Sub-adviser.

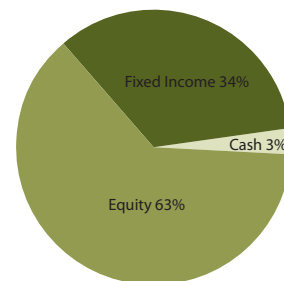
What You Should Know Before Investing

¹ The S&P 500 Index is a broad based index of 500 selected common stocks, most of which are listed on the New York Stock Exchange, that measures the U.S. stock market as a whole. Barclays Capital U.S. Government/Credit Index is an unmanaged non-securitized component of the Barclays U.S. Aggregate Index and was the first macro index launched by Lehman Brothers. The U.S. Government/Credit Index includes Treasuries (i.e., public obligations of the U.S. Treasury that have remaining maturities of more than one year), Government-Related issues (i.e., agency, sovereign, supranational and local authority debt) and USD Corporates. The Composite Index is intended to provide a single benchmark that more accurately reflects the composition of securities held by the First Focus Balanced Fund. The individual performance of each index that comprises the Composite Index is detailed in the chart on the reverse side. Sixty percent of the Composite Index is comprised of the S&P 500 Index and forty percent of the Composite index is comprised of the Barclays Capital U.S. Government/Credit Index. These indices are unmanaged and do not reflect the fees and expenses associated with a mutual fund. Investors cannot invest directly in an index.

² The Price-to-Earnings Ratio is a forward looking ratio which divides the current price of the fund by its estimated future earning per share. The Price-to-Book Ratio is used to compare a stock's market value to its book value. Beta is a coefficient measuring a stock's relative volatility. Standard Deviation is applied to the annual rate of return of an investment, to measure the investment's volatility or "risk". The Sharpe Ratio is used to characterize how well the return of an asset compensates the investor for the risk taken.

³ The Fund's Adviser is voluntarily reimbursing a portion of the Fund's expenses. If the Adviser had not reimbursed such expenses, the SEC 30-Day Yield would have been 5.81%.

For each fund with at least a three-year history, Morningstar calculates a Morningstar Rating™ based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a fund's monthly performance (including the effects of sales charges, loads, and redemption fees), placing more emphasis on downward variations and rewarding consistent performance. The top 10% of the funds in each category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars and the bottom 10% receive 1 star. (Each share class is counted as a fraction of one fund within the scale and rated separately, which may cause slight variations in the distribution percentages). For the period ended September 30, 2010, the Fund received 5, 4 and 5 stars out of 939, 755 and 413 Moderate Allocation funds for the three-, five- and ten-year periods, respectively.
