



Standard Deviation is applied to the annual rate of return of an investment, to measure the investment's volatility or "risk". The Sharpe Ratio is used to characterize how well the return of an asset compensates the investor for the risk taken.

For the period ended March 31, 2025, the Fund received 4 stars out of 582 and 4 stars out of 559 Small Blend funds for the three- and five-year periods, respectively.
